ASHBRIDGES BAY EROSION AND SEDIMENT CONTROL PROJECT Notice of Study Completion

Toronto and Region Conservation Authority (TRCA), in partnership with the City of Toronto, has completed the Ashbridges Bay Erosion and Sediment Control, Conservation Ontario Class Environmental Assessment. The study was undertaken to address the existing navigation risk caused by sediment deposition at the harbour entrance at Coatsworth Cut, while considering approved projects and waterfront planning initiatives in the area.

The preferred solution consists of three shore connected breakwaters which are designed to keep sediment from entering the Coatsworth Cut channel. A cobble beach integrates the breakwaters with other approved City of Toronto facilities located in the study area.

Opportunities for Review

The study was undertaken in accordance with the Conservation Ontario Class Environmental Assessment for Remedial Flood and Erosion Control Projects. An Environmental Study Report (ESR) has been completed and has been placed on public record for a 45-day review period starting Thursday December 18, 2014 and ending on February 1, 2015.
